

## **Explanation of Warning Labels**

#### **■**Before Use

Be sure to thoroughly read these precautions related to safety and operate the chair accordingly in a safe manner.

#### ■ About the Precautions Listed Here

The precautions continued herein are in order to ensure safe use, and to prevent any injury to users and other persons, and to prevent any damage.

All these precautions describe important items related to safety. Be sure to always obey all the precautions contained in this manual.

Takara Belmont has absolutely no responsibility for accidents that might be caused by failure to obey "Safety Precautions", "Use Precautions" and "Precautions Related to Synthetic (Natural) Leather" resulting in injury to users and other persons, or other damage. In such cases, the responsibility of any injury and damage lies solely with the user who fails to obey the "Safety Precautions", "Use Precautions" and "Precautions Related to Synthetic (Natural) Leather" and similar precautions.

A detailed explanation of the cautionary symbols is provided below. Be sure that you fully understand their contents before reading the rest of this manual.

## **MARNING**

#### Power Plug and Cord



- •Do not connect the earth (ground) to the following objects.
- Water pipes (Complete grounding is not possible as hard plastic pipes are widely used.)
- Gas pipes (Can result in an explosion or fire)
- Lightning rods and telephone dedicated grounding wire (Dangerous during lightning)
- •Do not place any objects on top of the power cord.

  Damage to the power cord can cause a severed wire or short circuit, resulting in electric shock or fire.
- •Do not touch the power plug, outlet or power switch with wet hand.

  Touching the power plug, outlet or power switch with a wet hand can result in electric shock.



- •Use a single outlet (do not share an outlet with other plugs).
  Use an unshared 230 V AC (12 A or more) outlet with an attached ground terminal.
  Using the same outlet together with the power plug of other devices can result in abnormal heat generation and possible fire.
- •Firmly insert the power plug into the outlet.

  Be sure to fully insert the power plug into the outlet until reaching the base of the plug.

  Failure to fully insert the plug or similar fault can result in a short circuit or heat generation that causes a fire.
- •Hold by the power plug when unplugging.

  Do not pull the cord to remove the power plug from the outlet. Hold by the power plug at the end of the cord when removing. Removing the plug by pulling the power cord can damage the power cord, resulting in electric shock or fire.
- •Be careful of power cord or plug breakage.

  Do not use any power cord or plug that is damaged, or that fits loosely when inserted into an outlet. Doing so can result in electric shock or fire.
- •Power cord replacement must be performed by a qualified person.

  If the power cord is damaged, it must be replaced by Takara Belmont, its distributors or similarly qualified persons in order to avoid a hazard.
- Securely connect to ground.
  - Failure to make a ground connection can result in electric shock if there is a malfunction or short circuit.

Consult an electrician for grounding procedures.



- •Unplug the power plug when the chair is not in use.
- Turn off the power switch and remove the power plug from the outlet when the chair is not in use.

Unexpected operation can result in an accident or fire from a short circuit due to insulation aging.

#### Installation/Transport



- •Installation precautions
  - •Installation of this chair must be performed by specialized personnel (personnel from Takara Belmont or Takara Belmont specified representative).
  - •The chair must be installed on a perfectly flat and solid floor. Installing the chair to a location with an angle of 5° or more can result in the chair tipping over.

## **MARNING**

#### Use and Cleaning Precautions



- •Be careful to keep hands, fingers and other body parts of the customer and user from touching or getting close to moving parts.
- There is a danger of pinching and other physical injury.
- Do not allow a customer to lie face down on the chair. Sudden operation of the chair can result in injury.
- •Do not stand on the edge of the footrest.

  Doing so could cause the chair to tip over or the footrest could suddenly move, resulting in injury or damage.
- Do not sit on the backrest of the chair.
   Doing so can result in injury or damage from the chair tipping over.
- •Only sit in the area designated for such use.

  Never sit on the headrest, armrests, edge of the backrest, legrest, or the footrest, or subject these to an excessive (more than necessary) load or force with the backrest reclined. Doing so can result in injury or damage from the chair tipping over.
- •Do not subject the leg or armrests to any excessive load or force. Doing so can result in injury or damage from the chair tipping over.
- •Do not use in an environment where there are electromagnetic interference waves. Do not install the chair near equipment that generates electromagnetic waves such as communication equipment and elevators. Do not use devices that generate electromagnetic waves (such as mobile telephones) near this chair. Doing so can result in faulty operation.
- •Do not wash the chair by pouring water on it.

  Washing in such a manner can result in a malfunction or electric shock.



- •Do not disassemble, repair or modify the chair.
  - •Disassembly or repair must only be done by a qualified service staff. Disassembly by yourself can result in an accident, a malfunction, electric shock or fire.
  - •Never modify this product. Doing so is dangerous.



- Precautions when getting in and out of the chair
- Always be sure to lower the chair to the lowest position and lock the rotation when a customer is getting in or out of the chair. Be especially careful when moving a person in a wheelchair in and out of the chair, and make sure that the wheelchair is not positioned in the operating range of the chair when moving the person. Feet, casters or other parts contacting the UP/DOWN switch will cause sudden operation of the chair, resulting in injury or damage.
- Precautions regarding customers and children
- Be careful to closely watch customers when using this chair. Customers (especially children) may touch the control switch inadvertently, leading to an unexpected accident due to incorrect operation of the product.
- This appliance can be used by children aged from 8 years and above and persons with reduced physical, sensory or mental capabilities or lack of experience and knowledge if they have been given supervision or instruction concerning use of the appliance in a safe way and understand the hazards involved.
- Children shall not play with the appliance.
- Cleaning and user maintenance shall not be made by children without supervision.
- Precautions when reclining/raising the backrest
  - •Check that the customer's hands or arms are not between the backrest and seat before reclining the backrest. There is a danger of pinching and other physical injury.
  - •Carefully recline the backrest so that the headrest or backrest will not contact any shampoo bowl or nearby equipment.
  - •Before raising the backrest, check that the customer's arms or hands are not in between the backrest and armrests, and operate it safely. There is a danger of pinching and other physical injury.

## **MARNING**

#### Use and Cleaning Precautions



- Precautions for chair operation and changing the preset positions
  - •Before operating the chair and during operation, thoroughly check that there are no bodies or limbs of persons, or possible obstacles in the operating range of the chair (ranges of seat raising/lowering, backrest reclining/raising, legrest operating directions, and seat rotation) or nearby. There is a danger of body parts being pinched by the chair, resulting in injury or damage.
  - •Check that the customer is seated in the proper position before operating the chair and closely watch the customer during chair operation.
- Precautions during chair rotation
  - •Make sure that no persons or objects are nearby before slowly rotating the chair.
  - •Be sure to always lock (secure) chair rotation after rotating the chair.
  - •Be careful of the customer when the backrest is reclined and check that the safety of the customer is ensured before rotating the chair.
  - •Adjust the adjuster on the backside of the footrest so that the power cord is not caught or pulled, and that the chair does not tip over even when stepping on the footrest.
- Precautions when removing/installing the footrest
  - •After installing the footrest, check that the footrest fixture is securely held by the guide and the footrest is not loose. Be careful that there is no looseness as this could result in the chair tipping over when the customer is getting in or out of the chair.
  - •Be careful when lifting and carrying the footrest, and of where you place it because the footrest is heavy. Dropping the footrest could result in serious injury or damage the floor.
- Precautions for the service outlets
  - •Be sure to fully insert the power plug of the device being used into the outlet until reaching the base of the plug. Failure to fully insert the plug or similar loose connection can result in a short circuit or heat generation that causes a fire.
  - •If the connection becomes loose, immediately stop using the device plugged into the service outlet, turn off the device power switch, and remove the power plug from the outlet.
  - Also, stop using the chair, turn off the power, unplug the power plug, and contact your closest dealer or Takara Belmont.
  - •Remove the power plug of a device from the outlet when not using it.
  - •If any water gets on a service outlet, immediately turn off the chair power switch, remove the plug, and wipe away the water. Additionally, if a substantial amount of water gets inside a service outlet, immediately remove the plug and contact your closest dealer or Takara Belmont.
  - •Do not touch a service outlet with a wet hand.
- Precautions when using the heater
  - •Using the heater for an extended period causes the temperature to increase, possibly resulting in burns or fire. Be sure to turn off the heater switch when not necessary.
  - •Turn off the power and remove the power plug if you feel abnormal heat when touching the legrest, and contact your closest dealer or Takara Belmont.
- Precautions when using the table
- Check that the table is securely inserted into the table securing slot before using the table. Failure to fully insert the table can result in the table falling off, causing injury and damage.
- •Be sure to always perform daily inspection.

  Failure to perform daily inspection can result in injury or damage.

  Refer to "Daily Inspection" on p. 33.

## **MARNING**

#### Use and Cleaning Precautions



- Turn off the power switch and unplug the power plug before cleaning.

  Failure to do so can result in electric shock or fire. Also, sudden movement of the chair while cleaning can result in injury.
- Procedures if a power outage occurs
  - •Turn off the power switch and remove the power plug of this product from the outlet in order to prevent unexpected operation when recovering from a power outage. Also turn off the power switches of all devices connected to the service outlet and remove the power plugs of devices.
  - •Be extremely careful if there is a power outage when the seat is in a high position as it is not possible to lower the chair. Assist the customer in getting in and out of the chair in that position, being very careful that the customer is not injured and the chair does not tip over.

## **CAUTION**

### Use and Cleaning Precautions



- •Do not allow any person whose weight exceeds 135 kg to sit in the chair. Doing so can cause the chair to tip over or faulty operation.
- •Do not strongly strike or scrape the chair.

  Doing so can result in tearing of covers and similar damage, and faulty operation.



- •Before use, confirm that every part is working normally and safely.

  Be constantly careful of and inspect for looseness, rattling, tilting, vibration, noise, temperature, odors and other possible problems. If you feel that something seems slightly different or not normal, immediately stop using the chair, turn off the power and unplug the power plug, and contact your closest dealer or Takara Belmont.
- •Always be sure to use your hands to operate the switches.

  Always be sure to use your hands to operate the switches except for the foot-operated UP/DOWN and rotation lock switches. Operating with something other than your hands can result in damage or faulty operation.
- •Be extremely careful not to mistake the switches when operating.

  The person operating the chair must pay careful attention to the surrounding area, give verbal warning, and properly operate the chair.
- Precautions when using the headrest
- •Be careful in pulling up the headrest more than necessary because doing so will make the headrest to come off the chair.
- •Be careful not to get water or any chemical on the headrest bar. Wipe off all water and chemicals immediately if any gets on these parts. Failure to do so can prevent the headrest from being securely fixed because of corrosion or degradation of friction force due to rust.
- •Be careful when operating the headrest that fingers and other body parts are not pinched between the area around the operating lever or in between the headrest and backrest.
- Precautions when using the cape holder
  - •Be sure to always return it to the stored state when not in use.
- •When storing the cape holder, be careful not to pinch the customer's or your own fingers between it and the armrest.
- •The cape holder can withstand a load of 10 N (1 kgf). Using the cape holder with an excessive load can result in damage or injury.
- •When using and storing the cape holder, please rotate the cape holder with hand.

### **A** CAUTION

#### Use and Cleaning Precautions



- •Precautions when adjusting the footrest adjuster
  Be careful when the adjuster is extended that it does not scratch the floor or pull the power cord when rotating the chair.
- Precautions when using the dryer/iron holder
  - •Be careful that the dryer or iron does not contact the legs or other body parts of the customer when using the dryer/iron holder.
  - •The dryer/iron holder can withstand a load of up to 20 N (2 kgf). Using the holder with an excessive load can result in damage or injury.
- •Immediately wipe off any chemical solutions or water that spills on the chair. Water or chemical adhering to a service outlet or control panel can result in faulty operation or a short circuit.
  - Immediately turn off the power switch, and wipe off any chemical or water that has adhered to the product by using a dry soft cloth.
- Precautions for cleaning procedures

  The metal and mechanical parts of the chair have sharp edges. Be careful when cleaning the chair that your hands, fingers or other body parts are not injured.
- Turn off the chair power switch after you are finished using it.

### **Use Precautions**

- •Immediately wipe off any chemical that spills on the chair. Immediately wipe off any chemicals adhering to the leather or pump cover. Failure to do so can result in deformation or discoloration.
- Do not apply heat
  - Doing so can result in deformation or discoloration.
- •Do not place any objects other than persons in the seat.

  Other objects can result in deformation or tearing of the leather, or corrosion.
- •Recline the backrest at the end of the day
  When you have finished working for the day, lower the chair to the lowest position and
  completely recline the backrest. This helps to extend the service life of the chair by not applying
  a load to springs and cylinders.
- •Do not use this chair for any applications other than hairdressing/beauty-related procedures. This product is designed for commercial use in barber shops and beauty salons. Only persons who are certified hairdressers or beauticians can be allowed to use this chair.
- •Do not use or store outdoors.
- Doing so can result in damage.
- Contact your closest dealer or Takara Belmont if the breaker function (p. 32) frequently operates.
- The maximum load is 1,350 N (135 kgf).
- The raising speed of the seat declines as the maximum load is approached.

### **Use Precautions**

#### • Rivet Specifications (AB-BROS\*M, AB-BROS\*A)

Rivet installation for rivet-specification chairs is performed manually and individually for each chair, thereby possibly resulting in uneven rivet lines, the heads of rivets being sunken or raised, differences in rivet color, and other differences.

The durability and resistance to wear of rivet color is reduced in comparison with regular rivets due to an antique-style plating used to enhance the texture, also making rivets easily damaged such as if scratched by finger nails or other sharp objects, or precious metals (such as rings and watches).

#### Discoloration of resin

Resin materials are used in external components of this product.

Carefully selected materials are used; however, discoloration may occur for reasons such as dnatural eterioration or the adherence of solutions. To ensure use of the product for longer period, immediately wipe off any solutions if it adheres, and avoid sunlight.

### **Precautions Related to Synthetic (Natural) Leather**

#### •Clothing dye adhering


The color of clothing or belts can be transferred to the synthetic leather of this chair by means of contact. If color adheres to the leather, wipe off the stain as soon as possible before it soaks in by using a soft cloth that has been dabbed with a neutral detergent diluted with water to approximately one tenth, wipe it with a damp cloth and thoroughly wipe it dry.

#### • Precautions regarding deformation and color transfer due to contact

- •Contact with other plastic parts, painted items, solvents, adhesive tape and similar items can result in changes in surface luster, cracking, deformation and peeling.
- •Contact with newspaper or other printed items can result in color transfer.
- •Contact with printed clothing such as t-shirts, jeans and similar items can result in color transfer such as by dye adhering to the leather.
- •Adhering benzene, nail polish remover, alcohol, oil and similar substances can result in discoloration, surface dissolution, changes in luster, hardening or softening and peeling.
- •Use of bleach, or use of a sheet or other cloth for which bleach has been used can result in changes in luster and color.
- •Placement of an iron, heater or other excessive heat source near the chair can result in deformation and discoloration.
- •Use a curtain or similar item to block the chair from exposure to direct sunlight. Exposure to direct sunlight can result in surface deformation, shrinking, discoloration, faded colors and similar problems.
- •Placement of a heavy item for an extended period can result in marks or wrinkles that do not disappear after removing the item.


### Power Supply

#### Inserting the power plug into the outlet

Type C Specification



Type BF Specification



Correctly insert the power plug into an outlet with a ground terminal.

- •Be sure to use a 230 V AC (12 A or more) outlet for the power supply. Do not share use of the outlet with any other electrical device.
- •Be sure to fully insert the power plug into the outlet until reaching the base of the plug.
- •Do not pull the cord to remove the power plug from the outlet. Hold by the power plug at the end of the cord when removing.




- **WARNING** •Do not touch the power plug, outlet or power switch with wet hand.
  - •Do not connect the earth (ground) to the following objects. Water or gas pipes, lightning rods and telephone dedicated grounding wire
  - •Consult an electrician for grounding procedures to ensure secure ground connections.
  - •Turn off the power switch and remove the power plug from the outlet when the chair is not in use.

#### **Turning on the power**

The power switch is located on the control panel (right).

Press the side with the \( \bar{\pi} \) mark to turn the power on and the side with the \( \bar{\pi} \) mark to turn the power off.




⇒When the power is turned on with the chair rotation lock released, the chair rotation is locked automatically.

**CAUTION** Always operate the power switch by your hands only.

### **Rotating the Chair**

Step on the rotation lock switch when locked to release the lock and enable rotation of the chair. The rotation lock repeatedly switches between locked and released each time that the rotation lock switch is stepped on.



Hold the backrest or armrests when rotating the chair. (You can rotate the chair a full 360°.)


- ⇒When the chair rotation lock is released, you can perform the following procedures to lock rotation.
  - •Turn on the power switch.
  - •Press the switches on the foot control and control panel (except for the legrest heater switch).
    - •Always be sure to lower the chair to the lowest position and lock the rotation when a customer is getting in or out of the chair.
    - •Be careful of the following when rotating the chair in order to ensure safety.
    - →Lower the chair to the lowest position.
    - →Do not rotate the chair until the customer has completely sat down in the chair.
    - →Always be sure that no other persons are in the surrounding area before rotating the chair, and rotate so that the footrest and other parts do not contact the customer or any nearby equipment.
    - •Always be sure to lock the chair when not rotating it.




### **Raising/Lowering the Chair**

You can raise and lower the chair by operating either of the switches.

The chair moves up and down while a switch is pressed.





⇒If the chair rotation lock is released, the chair rotation is locked automatically when you press the switch.



- •Before raising or lowering the chair, check that there are no body parts (especially hands or legs) or objects near the chair or footrest, or in the gap of the support arm.
- •This chair moves backwards as it is raised and forward as it is lowered. Thoroughly check that there are no obstacles in front of or behind the chair.

### Reclining/Raising the Backrest

#### **Pulling out the headrest**

Use the headrest when supporting the customer's head is needed, such as for shaving. Tip the headrest forward to fit it against the customer's head so that the customer will be more comfortable even if used for an extended period. Do not use the headrest if it is not needed, such as for back shampooing.

**1** Lift up the handle and pull up the headrest.


Remove your hand at the desired position to lock the headrest there.


If the headrest is pulled too far up, return it while pressing the headrest operation lever.

\* If the headrest comes off the chair body, press and hold the headrest operation lever while inserting back the headrest bar.

# **2** While pressing the headrest operation lever, tip the headrest forward.

The headrest can be fixed at 90 degrees. Push the headrest over so it is at 90 degrees and release the headrest operation lever.







### 3 Store the headrest when finished using it.

- (1) While holding the handle and pressing the headrest operation lever, return the headrest to its original angle.
- (2) Lower the headrest.

Press the headrest operation lever.




- •Do not apply excessive force to the headrest or strike it from above when it is pulled out. Doing so can result in damage.
- •Be sure to always store the headrest when performing a back shampooing. Otherwise, the shampoo bowl will interfere with the headrest possibly resulting in breakage.
- •To store the headrest, return the pressed-forward headrest to its original angle before lowering the headrest. Failure to return it to its original angle before lowering it can result in a strong force being applied to the leather of the backrest and corresponding damage to the leather.
  - •Be careful in pulling up the headrest more than necessary because doing so will make the headrest to come off the chair.
  - •Be careful not to get water or any chemical on the headrest bar.
    Wipe off all water and chemicals immediately if any gets on these parts.
    Failure to do so can prevent the headrest from being securely fixed because of corrosion or degradation of friction force due to rust.
  - •Be careful when operating the headrest that fingers and other body parts are not pinched between the area around the operating lever or in between the headrest and backrest.




## Reclining/Raising the Backrest

You can raise and recline the backrest by operating either of the switches.

The backrest rises or declines while the switch is pressed.





⇒If the chair rotation lock is released, the chair rotation is locked automatically when you press the switch.

When you recline the backrest without using the headrest, support the customer's head with your hand so that the customer will not contact with the shampoo bowl.




- •Check that the customer's hands or arms are not between the backrest and seat before reclining the backrest.
- •Carefully recline the backrest so that the headrest or backrest will not contact any shampoo bowl or nearby equipment.
- •Before raising the backrest, check that the customer's arms or hands are not in between the backrest and armrests, and operate it safely.


## Raising/Lowering the Legrest

You can raise and lower the legrest by operating either of the switches.


The legrest moves up and down while a switch is pressed.

The legrest of legrest-footrest linked type rises and lowers together with the footrest.









Independent legrest type

⇒If the chair rotation lock is released, the chair rotation is locked automatically when you press the switch.



- •Before raising the legrest (footrest), be very careful that the footrest or the customer's feet will not contact any nearby devices, and operate it safely.
- •Before lowering the legrest (footrest), make sure that no persons or objects are under the legrest (footrest), and operate it safely.


#### Using the preset function



Pressing the switch just once moves the chair to a preset position.

You can set up to three optional positions of this chair.







The chair can be moved to the preset positions for chair height, backrest angle and legrest position. The legrest of legrest-footrest linked type rises and lowers together with the footrest.

- \* Pull the headrest out to the desired position beforehand if you need to use it.
- ⇒If the chair rotation lock is released, the chair rotation is locked automatically when you press the switch.
  - •When using the preset function or Auto-return function, check that there are no people's body, hand, foot, or objects in the vicinity, then operate the chair.
  - •When an elderly customer or a small child is sitting down, the operation may be unexpectedly burdensome due to the posture change caused by the auto operation. Stop the operation immediately if you feel any abnormal changes.

### Using the auto-return function

The chair height, backrest angle and legrest position return to the position for getting in/out of chair. (An electronic "pough" sound is emitted to notify you that operation is starting.)





⇒If the chair rotation lock is released, the chair rotation is locked automatically when you press the switch.



- •When using the preset function or Auto-return function, check that there are no people's body, hand, foot, or objects in the vicinity, then operate the chair.
- •When an elderly customer or a small child is sitting down, the operation may be unexpectedly burdensome due to the posture change caused by the auto operation. Stop the operation immediately if you feel any abnormal changes.

#### Canceling an operation

Press any of the switches of the foot control or control panel (except for the legrest heater switch) if you want to suspend preset/auto-return operation.

(An electronic beep is emitted when the auto-return operation is stopped (canceled).)


#### **Adjusting preset positions**

Although the setting positions of the preset switches are previously set, you can change to the positions to match your needs and preferences.

Set the positions of the preset function with a person sitting in the chair.

The chair is equipped with a shockless device. Accordingly, the set positions vary slightly when a person sits in the chair if position setting is performed without a person sitting in the chair.

- 1 Move the chair to the desired seat, backrest and legrest positions, and turn the power switch off.
- **2** While pressing the preset switch (any of P1 to P3) for which you want to set these positions, turn on the power switch.
- 3 Continue to press and hold the preset switch for approximately three seconds. An electronic beep is emitted to indicate that the position has been set.



4 Return the chair to the position for getting in/out of chair by using the auto-return switch, and use the preset switch for which you have changed the setting to make sure that the chair moves to the position you have set.

### Using preset switch P3

Although the preset function of preset switch P3 can be used normally for the preset function, you can change the setting of P3 to a useful function that matches the desired customer use (last and facial positions).

\* The setting when purchased is "Normal Preset Function". If Changing the setting of p3, see "Setting Procedures" (p.23).


#### <Last Position Function>

You can use this function after you have finished cutting hair and moved the chair to the shampoo position by using preset switch P3. Press preset switch P3 again to return the chair to the position used for the cut.

This function is useful because you do not need to readjust the chair to the cut position, making for smooth and easy cutting.

Press preset switch P3 to move the chair to the preset position.


Press preset switch P3 again to return the chair to the position of when you previously pressed preset switch P3.



#### < Facial Position Function>


This function is useful as it allows you to recline and raise the chair without changing the chair height. For example, you can use this function if you want to reduce the work time or repeatedly check in the front mirror in the case of a facial service.

Only the backrest and legrest move to the set position (height does not change) when you press preset switch P3. Press preset switch P3 again to return the backrest and legrest to the position of when you previously pressed preset switch P3. (Height does not change.)



### <Setting Procedures>

(1) Turn off the power switch, step on the rotation lock switch, and push the backrest switch to the raise side while turning on the power switch.



(2) Continue to step on the rotation lock switch, and press the backrest switch for approximately three seconds until you hear any of the following electronic beeps. Check which function is set by checking the tone of the beep.

The setting changes in the following order:  $A \to B \to C \to A$  Perform procedures (1) and (2) repeatedly until reaching the desired function.



- A: Normal preset function ..... High-pitched beep
- B: Last position function ...... Beep is repeated twice.
- C: Facial position function ···· Beep is repeated three times.
- (3) If setting to the last or facial position function, first adjust the set position of preset switch P3 according to "Adjusting preset positions" (p. 21).
  - \* These settings are saved in memory even if the power switch is turned off.


### **Using the Cape Holder**


Using the cape holder:


- Provides space between the customer and the cutting cape to provide good ventilation.
- Makes it easy to clean up the cut off hair.
- 1 Rotate the cape holder at the edge of the armrest forward.



- 2 Pull out the tip of the cape holder and pinch the cutting cape between the parts.
  - (1) Pull from the top of the cutting cape








3 Rotate the cape holder rearward to store it.

Rotate the cape holder.




- •Be sure to always return it to the stored state when not in use.
- •When storing the cape holder, be careful not to pinch the customer's or your own fingers between it and the armrest.



- •The cape holder can withstand a load of 10 N (1 kgf). Using the holder with an excessive load can result in damage or injury.
- •When using and storing the cape holder, please rotate the cape holder with hand.

## Using the Dryer/Iron Holder

Pull out the dryer/iron holder at the center of the right side of the chair. You can use this as a stand for a hand dryer or iron while working.



- •Store the dryer/iron holder when not in use.
- •Do not rotate the dryer/iron holder with a hand dryer or iron still inserted in the slot. Doing so can damage the chair, and the heat can cause deformation or other damage.




- •Be careful that the dryer or iron does not contact the legs or other body parts of the customer when using the dryer/iron holder.
- •The dryer/iron holder can withstand a load of up to 20 N (2 kgf). Using the holder with an excessive load can result in damage or injury.

## **Using the Service Outlets**

This chair is equipped with one service outlet each on the right and left control panels.

Total current available for use with the two service outlets is 12 A or less when not operating the chair and 9 A or less when operating the chair.

The power switch (breaker) is turned off if the current available for use is exceeded. If this occurs, stop using the connected device(s), and turn on the power switch (breaker) again.





- •Be sure to fully insert the power plug of the device being used into the outlet until reaching the base of the plug. Failure to fully insert the plug or similar loose connection can result in a short circuit or heat generation that causes a fire.
- •If the connection becomes loose, immediately stop using the device plugged into the service outlet, turn off the device power switch, and remove the power plug from the outlet. Also, stop using the chair, turn off the power, unplug the power plug, and contact your closest dealer or Takara Belmont.
- •Remove the power plug of a device from the outlet when not using it.
- •If any water gets on a service outlet, immediately turn off the chair power switch, remove the plug, and wipe away the water. Additionally, if a substantial amount of water gets inside a service outlet, immediately remove the plug and contact your closest dealer or Takara Belmont.
- •Do not touch a service outlet with a wet hand.



### **Using the Heater**


This chair is equipped with a function to warm the legrest.

Press the legrest heater switch on the control panel (left) to operate the heater.

(The lamp of the switch lights up.)

The temperature adjustment function warms the customer's calves at an appropriate temperature when the heater is operating.

Press the switch again to stop the heater. (The lamp of the switch turns off.)



Use the heater with the legrest raised because heat will escape and the effective temperature will be reduced if the customer's calves do not contact the legrest.



- •Using the heater for an extended period causes the temperature to increase, possibly resulting in burns or fire. Be sure to turn off the heater switch when not necessary.
- •Turn off the power and remove the power plug if you feel abnormal heat when touching the legrest, and contact your closest dealer or Takara Belmont.

### **Accumulator**

#### (AB-BROSF/AB-BROSB only)

This chair is equipped with an accumulator that reduces vibration when operating and stopping the chair.

The accumulator absorbs loads applied to the hydraulic circuit of the chair to provide shock-free performance. Accordingly, the following conditions might be observed.

- •The stopping position of the chair might vary due to slowly stopping the chair in order to absorb shocks.
- •The chair might seem to slightly bounce due to load changes to the hydraulic circuit when getting in or out of the chair, or during massage.
- •The chair might rise slightly when a customer gets out of the chair. (Because the accumulator function has caused the chair to sink.)


Set the positions of the preset function with a person sitting in the chair.

The chair is equipped with a shockless device. Accordingly, the set positions vary slightly when a person sits in the chair if position setting is performed without a person sitting in the chair.

### **Using the Table**

#### (AB-BROSF/AB-BROSB only)

- **1** Insert the table into one of the table securing slots at the edges of the armrests until the inserted part of the table is fully and securely inserted.
- **9** Hold the main part of the table and pull out to remove.



- •Do not insert/remove the table or operate the chair with items on the table. Doing so can result in such items falling off or in spilling of liquids.
- •Do not place objects on the table that weigh 2 kg or more, or items that hang over or extend beyond the table surface. Doing so can result in damage to or deformation of the chair or table.
- •Do not use the cape holder when using the table. Doing so can result in damage to or deformation of the cape holder or table.
- •Be careful that nearby devices such as the shampoo bowl do not interfere with the table when rotating or operating the chair while using the table.




Check that the table is securely inserted into the table securing slot before **CAUTION** using the table. Failure to fully insert the table can result in the table falling off, causing injury and damage.

### **Using the Foot Cushion**

#### (AB-BROSF only)

This chair has a foot cushion that can be placed on the footrest on which the customer's legs can rest in order for the customer to recline with comfort.

Use it for customers whose height is such that their heels extend beyond the legrest.




Always be sure to remove the foot cushion before returning the legrest to its original position. Returning the legrest with the foot cushion still located on the legrest can result in the cushion being pinched between the legrest and footrest.

## **Aligning with the Yume Swing Bowl**

#### (AB-BROSF/AB-BROSB only)

This chair is equipped with a "Yume Swing Position Setting Function" in the chair base that detects position in order to be able to properly align the positions of the Yume Swing bowl and chair rotation.

- 1 Release the rotation lock and rotate the chair.
- 2 Rotation becomes slightly heavy as you slowly rotate the chair until it is near the Yume Swing bowl position and you feel a slapping click.
- **3** After the chair is secured at the position in 2, you can press a previously set preset switch to align the chair and Yume Swing bowl at the proper position.




- •Lock the chair at the Yume Swing position so that the Yume Swing position and the bowl are aligned at the proper position, and check that the chair and bowl are properly aligned.
- •Reposition the Yume Swing position to the proper position after moving the chair for cleaning or similar reason because the position might become misaligned due to such movement.
- •The Yume Swing position setting function has a simple lock for position detection. Always be sure to fully lock it by using the rotation lock switch after aligning the position because the lock can be released with only slight force.



For front-layout Yume Swing bowl


Front power cord side

### **Removing the Footrest**

You can remove the footrest anytime it might interfere such as when sitting a wheelchair customer in the chair or using a foot spa machine.



#### **Removing the footrest**

Pull up the footrest at an angle (approx. 45°) with both hands and pull it up towards you to remove it.

### **Installing the footrest**

Install by performing the removal procedures in the reverse order.

Hook the footrest fixture on the guide while aligning with the positioning stoppers.

- ⇒The adjuster, which prevents the chair from overturning, is located on the underside of the footrest. Adjust the adjuster by loosening the adjuster nut by using a wrench (No. 17), adjust the height of the adjuster, and then tighten the adjuster nut by using a wrench (No. 17), as shown in the figure above.
- •Be careful of operating the chair when using a foot bath and make sure that the chair does not interfere with the foot bath.
- •Immediately wipe off any water, chemical or other liquid of the foot bath if it gets on the chair.



- •After installing the footrest, check that the footrest fixture is securely held by the guide and the footrest is not loose. Be careful that there is no looseness as this could result in the chair tipping over when the customer is getting in or out of the chair.
- •Be careful when lifting and carrying the footrest, and of where you place it because the footrest is heavy. Dropping the footrest could result in serious injury or damage the floor.

### / CAUTION

Be careful when the adjuster is extended that it does not scratch the floor or pull the power cord when rotating the chair.

### **Cleaning Procedures**

Clean this chair after use to maintain it in a clean state.

Leaving dirt or grime on the chair can result in the formation of mold.

### **⚠ WARNING**

- •Turn off the power switch and unplug the power plug before cleaning. Failure to do so can result in electric shock or fire. Also, sudden movement of the chair while cleaning can result in injury.
- •Do not sprinkle with water to clean it. Washing in such a manner can result in a malfunction or electric shock.

### **↑** CAUTION

The metal and mechanical parts of the chair have sharp edges. Be careful when cleaning the chair that your hands, fingers or other body parts are not injured.

### **Cleaning of Each Part**

Lightly wipe clean using a dry soft cloth.

#### **Leather Parts Plastic Parts**

If extremely dirty

Wipe off any stain by using a soft cloth that has been dabbed with a neutral detergent diluted with water to approximately one tenth, wipe it with a damp cloth and thoroughly wipe it dry.

Wipe clean using a dry soft cloth.

**Control Panels** Do not clean these parts with a wet cloth because they are readily affected by moisture and water. Wipe off all moisture immediately if any water gets on these parts. Water left on these parts will result in rust or malfunction of electronic parts.

- •Do not use any of the following substances to clean the chair.
- Thinner, alcohol, nail polish remover, volatile chemicals (such as gasoline or kerosene), acid or alkaline solutions, chlorinated cleaners, disinfectants that are highly corrosive to metal, povidone iodine (iodine solution), sodium hypochlorite, waxes containing abrasive compounds, sponges containing abrasive compounds and similar substances.
- •Do not use brushes, scouring brushes or similar items when cleaning the chair. Using them will damage the chair or result in the inability to clean off the dirt or grime.
- •Do not clean leather parts using a cleaner or bleach containing organic solvent or abrasive compounds. Such substances can cause the leather surface to deteriorate or dull the luster.

Clean a chair that has not been used for an extended period before using again. After cleaning, be sure to always check that the chair operates properly.

### Spray-type Hairstyling Products (Especially hard types)

When using spray-type hairstyling products (especially hard types), check the entire chair to make sure that none of the product is adhering to the exterior surface of the chair (including leather parts). Immediately wipe off any hairstyling product that is adhering to the chair. Allowing such hairstyling product to remain results in it becoming firmly adhered, leaving a feeling of roughness. Be especially careful of flat surfaces (such as the plastic covers) as this roughness is considerably noticeable on flat surfaces.

\* If hairstyling product has become firmly adhered: Clean off any firmly adhered hair product by using ethanol. However, repeatedly cleaning off product adhering to plastic covers and leather parts by using ethanol can cause the surface to deteriorate, paint to peel, the luster to be lost, and cracking. To prevent this, immediately wiping off any adhering hairstyling product is the best method to prevent any problems.

## **Troubleshooting**

If any of the problems described below occur, conduct the checks outlined before requesting repair. If the chair does not work normally even after performing the recovery procedures, immediately stop using the chair, turn off the power, unplug the power plug, and contact your closest dealer or Takara Belmont.




