1. OVERALL VIEW AND MAJOR PARTS




Fig.1-1 Overall View and Major Parts




Fig.2-1 Dimensions

Note: SP-PSB, SP-PSW have the side up switch for shampoo positioning.

3. PREPARATIONS

(1) CHAIR SETTING POSITION




Fig.3-1 Chair Setting Position

Basic chair setting position is shown in Fig.3-1.

(2) UNPACKING

CAUTION

Do not use sharp instrument to open carton box. Lift Up by only the base plate.

- A. Place the carton box behind the planned location for the chair.
- B. Open the carton box.




Fig.3-2 Red Tagged Oil Plug

- C. Lift up with holding the base plate and take out from the carton box. (Fig. 3-2)
- D. Place the base on the planned location for the chair.

(3) PREPARATIONS

/ CAUTION

Operate the main switch only by hand.

Take proper earth (ground) at any time.

Turn off the main switch in long term interval.

- A. Pull out the red tag and remove the oil plug. (Fig.3-2)
- B. Plug the power supply cable in suitable power supply outlet.




Fig.3-3 Main Switch

- C. Turn on the main switch located on the rear pump cover. A lamp illuminates in the main switch. (Fig.3-3)
- D. Lift up by the foot switch to suitable height for setting upper section.

(4) SETTING UPPER SECTION




Fig.3-4 Setting Upper Section

Keep lining up the seat flange ditch to the rotation shaft roll pin and insert the rotation shaft into the seat flange firmly. (Fig.3-4)

Note: Seat flange is fixed under the upper section.



Do not lift up by upper section. Lift up by only base plate.

4. OPERATING INSTRUCTIONS



Before operating the chair, confirm safety for the customer and the operator. Do not let a person sit on or leave the chair except at the lowest chair position. Do not load heavy weight on the step.




Fig.4-1 Main Switch

(1) MAIN SWITCH (Fig.4-1)

Turn on the main switch located in the rear pump cover. A lamp in the main switch illuminates.




Fig.4-2 Foot Switch

(2) CONTROLS (Fig.4-2)

A. Lifting

Keep depressing the up switch until the chair is lifted up to the desired position.

B. Lowering

Keep depressing the down switch until the chair down to the desired position.




Fig.4-3 Chair Rotation

(3) CHAIR ROTATION (Fig.4-3)

! CAUTION

Do not use the chair at unlocked position.

Turn the chair upper section with holding the backrest or armrest to release the lock. The chair upper section can be rotated freely.

The locking position is located front side and rear side.

5. CARE AND MAINTENANCE

Other than cleaning, no scheduled maintenance.

Paint parts, plastic parts can be cleaned with a weak neutral detergent.

/ CAUTION

Turn off the main switch with the lowest position after daily use or in long term interval. Do not drench the base for cleaning.

Do not use polishing powder, solvents and strong disinfectant for cleaning.
